

Did you know?

- Tribal-direct offers expedited time to award (timeline decreased from 1.5 years to 4 weeks).
- Decreased costs and positive impacts to budget with reduced spending for procurement.
- No Sole Source Dollar Threshold as per 13 C.F.R. 124.506(b).
- Without Justification & Approval (J&A), the SBA may award a sole source 8(a) contract to a Tribal 8(a) firm with a value:
 - ∘ ≤ \$25M (Federal Agencies)
 - ≤ \$100M (Department of Defense)
- With approved J&A, NO dollar threshold for Tribal sole source award.
- Supports flexible and scalable program requirements.
- Non-Protestable as per 13 C.F.R. 124.517(a).

Contracting Beyond Tribal Direct

• Multiple contract vehicles are also available including OASIS SB Pools 1,2,3 and 8(a) Subpools 1,2,3, GSA HCaTS, 8(a) STARS III, and SeaPort-NxG.



- 1. Develop Statement of Work.
- 2. Identify budget.
- 3.Submit Sole Source Solicitation to SBA (response received within 5 days).
- 4. Award Contract.
- 5. Work begins.


